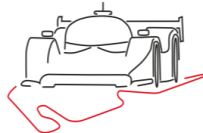

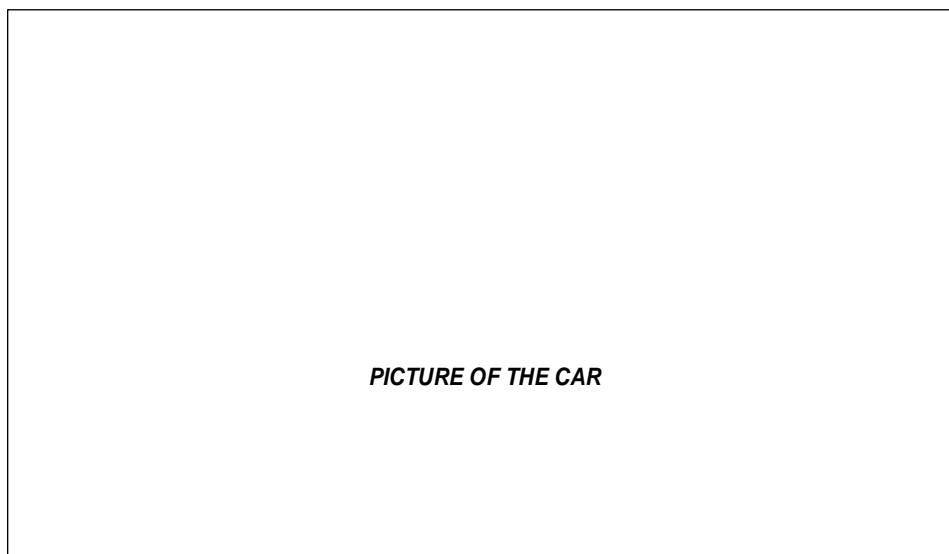

The Main Competitors and/or Co-Drivers and/or Vehicle Owners agree to perform and abide by the following terms and conditions:

Terms for Participation:

In consideration of Gebhardt Marketing & Service GmbH ("**Gebhardt Marketing & Service**") acceptance for participation in Gebhardt Marketing & Service Events this year, the Undersigned owner, competitor, driver and/or co-driver of race car(s) accepted for such Event(s) ("**Participants**"), on behalf of himself/herself and his/her respective next of kin, personal representatives, successors, and assigns, hereby:

- a. Releases, waives, discharges the promoters, participants, racing associations, sanctioning organizations, Gebhardt Marketing & Service track operators, track owners, track officials, track employees, car owners, drivers, mechanics, pit crews, corner workers, stewards, race officials or other vicarious agents of Gebhardt Marketing & Service and any persons in any restricted area during the Events, rescue personnel, advertisers, sponsors, owners and lessees of the Event venue, and Event inspectors, scrutineers, surveyors, underwriters, consultants and others who offer recommendations, directions and instructions or engage in risk evaluation or loss control activities relating to the Event, and each of them, and each of their respective officers, directors, agents, legal representatives, employees, contractors, members, consultants, affiliates, successors and assigns (collectively referenced herein after as "**Releasees**") from all liability to the Undersigned, and his/her personal representatives, successors, assigns, heirs and next of kin for any and all loss or damage to property, and any claims or demands therefor, on account of damage to property of the Undersigned, arising from or related to the Event(s) caused by the simple negligence of the Releasees or the persons for which they are responsible.

The Releasees shall be unrestricted liable for damage to property caused intentionally or with gross negligence by the Releasees or the persons for which they are responsible.

The Releasees shall be unrestrictedly liable for death, bodily injury or damage to health caused by at least negligence of the Releasees or the persons for which they are responsible.

- b. Acknowledges that motor racing and other competition Events are dangerous for Participants, as well as spectators, mechanics, safety workers, and others within the Event venue, and involves the risk of serious bodily injury, death and/or property damage.
- c. Releases his/her co-competitors and their co-drivers from all liability to the Undersigned and his/her personal representatives, successors, assigns, heirs and next of kin for any and all loss or damage, and any claims or demands therefor, on account of damage to property of the Undersigned, arising from or related to the Event(s) caused by the simple negligence of the other Participants or the persons for which they are responsible.

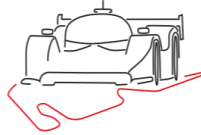
The Participants shall be unrestricted liable for damage to property caused intentionally or with gross negligence by the Participants or the persons for which they are responsible, or if the co-competitor or their co-drivers violate the regulations in relation with the race, in particular the letter and spirit of FIA and/or the Master Technical and Sporting Regulations and/or the Group-C regulations.

The Participants shall be unrestrictedly liable for death, bodily injury or damage to health caused by at least negligence of the Participants or the persons for which they are responsible, or if the co-competitor or their co-drivers violate the regulations in relation with the race, in particular the letter and spirit of FIA and/or the Master Technical and Sporting Regulations and/or the Group-C regulations.

- d. Agrees to defend, indemnify, and hold harmless the Releasees, and each of them, from any loss, liability, damage or cost they may incur arising out of or related to damage to property of the Undersigned, or otherwise arising from or related to the Undersigned's participation in the Event(s).

This does not apply to damages due to gross negligence or intent on the part of the Releasees or the persons for which they are responsible, or to injuries to the body, health, or life of the Undersigned.

- e. Represents, warrants, and confirms that the race car entered and described in this application meets both the letter and spirit of FIA and/or Master Technical and Sporting Regulations (which the Undersigned acknowledges having read and understood) currently in force for the Class in which such car is entered and, having consulted with the race car preparer, that such race car meets applicable safety requirements and is otherwise fit for competition.
- f. Represents, warrants, and confirms that he/she has read and understand the relevant Gebhardt Marketing & Service, FIA, DMSB and all other applicable rules and regulations.
- g. Represents, warrants, and confirms that he/she has read, understands and agrees to abide by the rules of the Club, Hockenheim Circuit, Assen Circuit and DMSB.
- h. Represents, warrants, and confirms that he/she has no known health issues or problems that may affect participation in the race series and will notify Gebhardt Marketing & Service and/or refrain from participation in the race series if there are any changes of such circumstance during the season.
